## INFORMATION AND RULES FOR EXHIBITORS

EXHIBITOR is to provide wiring for its exhibit from the point of connection. Exhibitor is to provide protective devices of the proper size for its exhibit's wiring requirements. Hookup and Disconnection is to be performed by the Clarion County Fair electrician. A security deposit will be held by the electrician, which will be returned when exhibitor has been properly disconnected.

EXHIBITORS using water must have the appropriate back flow prevention equipment at point of access.

CLEANING – The Clarion County Fair will clean the midway and the aisles of the main display tents & buildings. Each EXHIBITOR is responsible for cleaning their own space. Refuse to be placed in rubbish containers only.

SUBLETTING - No space may be sublet by an exhibitor.

SOUND SYSTEMS - NO public address systems are allowed, except those provided by the Fair.

PERSONS using alcohol or other controlled drugs or substances will be expelled from the grounds.

THE BOARD reserves the right to terminate leased space of any exhibitor that displays or sells obscene or dangerous materials.

PARKING AND TRAFFIC – Adequate parking space for exhibitors is provided. Traffic on the Midway or streets of the Fair is prohibited after 11:00 A.M.

GAMES, wheels, shows, etc. in violation of the Laws of the Commonwealth, are not permitted. Space paid for under a misrepresentation of Facts shall be forfeited without claim for damages, or refund of money paid.

ALL displays or stands must remain at their assigned spots until 9:00 P.M. on Saturday of the Fair week.

EXHIBITORS will be furnished two (2) weekly passes to the fair grounds. These passes are not good for the rides or field shows. Additional passes may be purchased at the Fair office.
