AGREEMENT FOR RENTING OF SPACE AT THE CLARION COUNTY FAIR -----ONE CONTRACT FOR EACH SITE.

TERMS: EXHIBITOR SPACE WILL NOT BE RESERVED UNTIL 25% OF THE SPACE CHARGE IS PAID. ALL SPACE CHARGES MUST BE PAID IN FULL BY JULY 1ST, 2022. Payments made to reserve space will be refunded if the space is cancelled by June 1st, 2022. Exhibitors MAY NOT make electrical or water hookup without Fair approval. Contracts must be returned by July 1st, 2022. The Fair runs from Sunday through Saturday. Set up is preferred on the Saturday before the fair starts. (Exceptions will be made on a case-by-case situation).

RATES: All space is available in ten (10) feet minimum frontage. Additional space is in multiples of five (5) feet.

Non-Profit Vendor Spots: First ten (10) feet are free. Anything over ten (10) feet will be charged \$10.00 per foot front. Non – Profit Vendor over ten (10) will get 2 wrist bands/passes per paid spot. Non – Profit spots at ten (10) feet must pay for all wrist bands/passes for the week. Bands/passes can be bought in the Fair office. (Wrist bands/passes DO NOT get you rides or grandstand seating) Parking for all vendors is designated outside gate #2. Electric for Non-Profits is first come, first served after For Profit is accommodated.

For Profit Vendor Spots: \$20.00 per foot front, minimum of ten (10) feet. This price includes electric for twinkle lights. An up-charge will be charged for the use of refrigerators, heat presses, beverage coolers etc., at a rate of \$15.00 per unit. This price gets you 4 bands/passes. Any extra can be bought for \$10.00 each. Bands/passes can be bought in the Fair office. (Wrist bands /passes DO NOT get you rides or grandstand seating.) Parking for all vendors is designated outside gate #2.

Premier Vendor Spots: These spots are located outside the grandstand. These spots have greater exposure; therefore, the cost of these spots is \$25.00 per foot front. This price gets you 6 bands/passes. Any extra can be bought for \$10.00 each. Bands/passes can be bought in the Fair office. (Wrist bands/passes DO NOT get you rides or grandstand seating.) Parking for all vendors is designated outside gate #2.

INFORMATION AND RULES FOR ALL VENDORS

THE VENDOR AGREES TO ABIDE BY THE RULES SET FORTH BY THE CLARION COUNTY FAIR

VENDOR is to provide wiring/cords (12 gauge or larger) for its exhibit from point of connection. Vendor is to provide protective devices of the proper size for it's exhibits wiring/electric requirements.

VENDOR using water must have the appropriate backflow prevention equipment at point of access.

CLEANING ---- The Clarion County Fair will clean the midway and the aisles of the main display tents and buildings. EACH Vendor is responsible for cleaning their own space. Refuse is to be placed in trash containers only.

SUBLETTING----- NO space may be sublet by any exhibitor.

SOUND SYSTEMS---- No public address systems are allowed, except those provided by the Fair.

DRUGS/ ALCOHOL---- Persons using alcohol or other controlled drugs or substances WILL be removed from the grounds.

The Board reserves the right to terminate rented space of any vendor that displays or sells obscene or dangerous materials.

Parking and Traffic---- Adequate parking space for vendor's is provided outside of gate #2. Traffic on the Midways or streets of the Fair is prohibited after 11:00 am.

Games, wheels, shows, etc. In violation of the Laws of the Commonwealth are not permitted. Space paid for under a misrepresentation of facts shall be forfeited without claim for damages, or refund of money paid.

All displays or stands must remain at their assigned spots until 9:00 pm on the last day of the fair week.

Letters of Intent--- Letters of intent for the next year's fair will be given at time of setup. Letters need to be turned into the office before the end of the week.

All vendors must provide a valid certificate of insurance on or before setup. Clarion County Fair and its board along with the Redbank Valley Municipal Park and its representatives must be named as an additional insured and appear as certificate holders. Commercial General Liability including products/ completed operations limits \$1,000,000.00 each occurrence, \$1,000,000.00 aggregate.

~HOLD HARMLESS AGREEMENT~

To the fullest extent of the law, the VENDOR shall indemnify and hold harmless the Clarion County Fair, its agents, and employees, the Redbank Valley Municipal Park from and against claims, damages, losses and expenses, including but not limited to attorney's fees, arising out of or resulting from the presence of the VENDOR at the Clarion County Fair, provided that such claim, damage, loss or expense is attributable to bodily injury, sickness, disease or death, or to injury or destruction of tangible property including loss of use resulting therefrom, but only to the extent caused in whole or in part by negligent acts or omissions of the VENDOR, anyone directly or in directly employed by them or anyone for whose acts they may be liable, regardless of whether or not such claim damage, loss or expense is caused in part by a party indemnified hereunder.
