### AGREEMENT FOR PURCHASE OF SPACE AT THE CLARION COUNTY FAIR

**TERMS:** No space will be reserved for an exhibitor until 50% of the space charge is paid; all space charges must be paid in full by 6:00 p.m., Wednesday, third day of Fair. Payments made to reserve space will be refunded if the space is cancelled by June 1. Exhibitors may not make electrical or water hookup without Fair approval. Contracts must be returned by June 1. Exhibitors who do not have their exhibits erected by 2:00 p.m. of opening day will forfeit their space.

#### *HOLD HARMLESS AGREEMENT*

To the fullest extent of the law, the EXHIBITOR shall indemnify and hold harmless the CLARION COUNTY FAIR, its agents, and employees, the Redbank Valley Municipal Park from and against claims, damages, losses and expenses, including but not limited attorney's fees, arising out of or resulting from the presence of the EXHIBITOR at the Clarion County Fair, provided that such claim, damage, loss or expense is attributable to bodily injury, sickness, disease or death, or to injury or destruction of tangible property including loss of use resulting therefrom, but only to the extent caused in whole or in part by negligent acts or omissions of the EXHIBITOR, anyone directly or in directly employed by them or anyone for whose acts they may be liable, regardless of whether or not such claim damage, loss or expense is caused in part by a party indemnified hereunder,
